1. General Updates from the President

1.1 SUS President's Table:

The SUS President's Table will be rotating between the UFV campuses on Mondays throughout the Fall semester. The SUS President's Table has been to the Mission and Chilliwack campuses this month and will be in the SUB next week for Mental Health Awareness Week/Peer Leader Appreciation Week. 1.2 UFV Community Flag Display:
